SUMMARY OF OFFENSES AND PROBABLE CAUSE AFFIDAVIT:

The following probable cause was derived from police reports written by officers who responded to this incident:

Initial Call for Service- June 3rd, 2023 at 11:15am

On June 3rd, 2023, Ofc C. Babb was dispatched to 1229 Continental Court in reference to a missing juvenile, Lori Paige.

Upon arrival Ofc Babb spoke with the caller, Andrew Wiley, and he advised the following:

Andrew Wiley is the father of twelve-year-old Lori Paige. Lori lives at the residence with Wiley and has been living there for over a year. Wiley explained he left for work on June 2nd, 2023, around 11PM and returned home on June 3rd, 2023, at 10AM. Wiley left Paige in the residence watching television prior to going to work. Wiley advised Paige was safe and uninjured. Wiley said he does not know what Paige is wearing but knows she took her multicolored (rainbow style) backpack.

Ofc Babb asked Wiley to provide some background information on Lori.

According to Wiley, Paige use to live with her mother, Maranda White in Tennessee. Maranda White no longer cares for Paige. Wiley explained White asked for a check on welfare from law enforcement roughly a week prior (call for service on 5/25/23). Shortly after law enforcement left, Maranda White arrived and argued with Paige. White and Paige do not get along and argued extensively while White was visiting. After White left the residence, Paige began saying she was worthless, and her mother did not love her. Paige has a history of running away in Tennessee but only one prior incident in Tallahassee (reference case#23-81621).

On May 8th, 2023, Paige was reported missing. Paige was last seen at Griffin middle school and was found the next day in an abandoned apartment, 1001 Ocala Road apartment 240.

Ofc Babb notified Maranda White that Lori Paige was missing via telephone. Ofc Babb asked White to contact police if she learned anything regarding her daughter's whereabouts. White explained she was there roughly a week prior but has not talked to Lori Paige since.

Ofc Babb asked Wiley to describe Lori Paige. Wiley described Paige as a black female roughly 5 foot tall. Paige has shoulder length black dreads. She has no significant scars, marks, or tattoos. He does not know what Paige was last wearing. Wiley explained she took her multicolored (rainbow style) backpack prior to leaving. Wiley provided Ofc Babb with a recent photo of Paige.

Andrew Wiley was unsure if Lori Paige takes any medications. He did not know if Paige has any medical or mental health issues. Wiley explained Paige did not have her phone because he confiscated her phone before the last time she ran away. It was confirmed the last time Lori attempted to call or contact anyone was on 4/17/2023.

Andrew Wiley explained to Ofc Babb that he did not know why Paige would run away. According to Wiley, everything was alright and there was nothing concerning prior to him leaving for work. Andrew Wiley could not provide Ofc Babb with any locations where she could be and allowed officers to inspect the home for any sign of foul play. The residence was inspected by responding officers with no signs of foul play indicated.

Ofc Babb notified TPD Special Victims Unit Detective Drake, who put out a missing person flyer.

Ofc Babb was able to determine Lori's grandmother, Brooklyn Paige, lives at 1332 Arkansas Street. Officer Brannon made contact and determined Lori Paige was not at the residence. Officer Brannon also checked Griffin Middle School and was unsuccessful in locating Lori Paige there. Lastly, Officer Brannon checked the last location to where she was known to runaway, 1001 Ocala Rd apartment 240, and was unsuccessful in locating Lori Paige there.

Officers checked nearby parks and spoke with multiple individuals walking around the parks and with no sightings of Lori Paige

Lori Paige was then entered in NCIC/FCIC as a missing person.

The following is a compilation of investigative steps conducted by the then case agent, Det A. Drake:

Det. Drake contacted a friend of Lori Paige, Diamond Ivey on 06/05/2023 who advised she has not spoken to Lori Paige since school was released for the summer because Lori Paige does not have a cell phone or social media that can be used on a computer.

Det Drake spoke to the leasing office at 1001 Ocala Rd, and they advised that the subject who harbored Lori Paige last time, Pierre Donaldson, had moved. It was later determined his family still lived in the apartment complex but at a different apartment. Donaldson would be interviewed later in the investigation.

On 06/07/2023, Det Drake went to [REDACTED]. Deputy Swain had spoken to [REDACTED] who rides the bus with Lori Paige and lives at [REDACTED]. [REDACTED] advised that he does not know where she is, but that she is "still around" the area.

On 06/09/2023, Det Drake canvassed area apartment complexes and did not locate her.

On 06/12/2023, Det Drake asked [REDACTED] to send Lori Paige's flyer to all 6th grade parents in case she was staying with a friend and lying to the parent about permission.

On 06/13/23, Det Drake spoke to Andrew Wiley's girlfriend, Symone Robinson, who is in Louisiana for military training. She advised that Paige does not use social media, but she plays Roblox and watches YouTube a lot.

On 06/16/2023 Det Drake went to Dade Street Community Center who advised Paige has come by after school, but they have not seen her since school ended. Det Drake canvassed areas close to where Lori Paige had gone missing in the past and canvassed public transportation depots without success. Missing Persons fliers for Lori Paige's case were posted at these locations.

On 06/19/2023 Paige's information was provided to FDLE's MEPIC and they communicated the information to Tennessee Clearing House. Calls from Det Drake were attempted to Maranda White (mother) and Brooklyn Paige (grandmother)

without any immediate answer or return call. Andrew Wiley was contacted for information regarding dental records for Lori Paige but claimed to not know if or when she was ever seen by a dentist.

Brooklyn Paige allowed officers into her home to search. Brooklyn advised that Paige really liked her mother's former boyfriend in Tampa, Maurice Jones. She provided phone numbers for Jones, but Det Drake would not be able to contact him.

Flyers were distributed to hotels, motels, and extended stay facilities throughout the city. As leads regarding sightings were called into the police department, they were investigated and determined too unsubstantiated.

On 06/20/2023 Nashville Youth Services and the Runaway Bureau advised that they only had record that Paige ran away once but returned quickly thereafter. [REDACTED]

Detectives of the Special Victim's Unit (SVU) were assigned to conduct surveillance on known associates of Lori Paige. Detectives did not observe any indications that Paige was with family or friends.

On 7/24/2023, Maranda White provided two Gmail accounts for Lori Paige as paigelori666@gmail.com and Plori14.lp@gmail.com. By 08/31/2023 Google, Inc responded to a search warrant with records from paigelori666@gmail.com. Paige was not communicating with anyone other than her mother over email and had no communication with her since her disappearance. The email had not been accessed after 03/07/2023; however, there were introduction emails from several social media websites to include:

Search warrants were submitted for all above listed accounts without success. It was apparent that although each account had been activated, none were used after activation.

On 07/24/2023 a request was made to Leon County Schools for records related to email, search history, web history, and messaging on the school Chromebook. It was determined that these records were unavailable due to the computer reassignment and resetting.

In August of 2023, after Lori Paige had been missing for more than two months, Andrew Wiley allowed detectives to process his residence using a bioluminescent compound which reacts to blood evidence visible and not visible to the naked eye. No suspected blood was located after this processing.

By 8/30/23, dental records were finally obtained from Maranda White and promptly entered to FCIC/NCIC with no resulting matches.

By this point in the investigation, 3 attempts had been made to gather a buccal DNA sample from Maranda White through the Nashville Metro Police Dept. White was reluctant to provide any sample to police.

On 01/08/2024, Maranda White posted a status on her Facebook page stating, "My baby is gone [broken heart emoji]." And promptly removed it. When questioned about it, she advised she meant Lori is not with her and she knows in her soul that Lori is dead.

In January of 2024, Det. Mrowiec went with other officers of Nashville Metro Police Dept to contact Maranda White and her wife, Latonya White at their residence of 1720 Windover Dr in Nashville, TN. Latonya White advised neither she nor Maranda had contact with Lori since she went missing. Detectives did not note anything indicative of a 12-year-old child living there. The upstairs family who owns the home advised they have never seen Lori or any children other than the young boy (Latonya's son).

On 1/31/24, Det. Megna and Det. Collins contacted Andrew Wiley at his new residence in Thomasville, Georgia. The following information was learned during the interview:

Wiley was asked if there was anyone from his old neighborhood that he was concerned about or could have anything to do with what happened. Wiley then stated he was unaware of Lori's friends, and he knew that when she ran away the first time, she was in an abandoned building with a boy (however she was recovered at school but reportedly slept at an abandoned building). Wiley stated his only relationship with Lori prior to her coming to live with him Tallahassee was when she was 5 years old, and they lived in Miami. Lori came to live with him this time in June of 2022 to stay for the summer. Then when Maranda was supposed to return, she advised she would not return to get Lori. Andrew enrolled Lori in school and she continued to live with him. Andrew noted she was three weeks late being enrolled into school because of trying to get records and information. Andrew said his brother (Antwan) was assisting him. Andrew stated he and Maranda do not communicate since this occurred or ever in general. He noted that he and Maranda never had much of relationship but after Lori was born, Maranda took her to Tampa. Andrew did not see Lori until [REDACTED]

Lori did not have any electronics other than a phone which she only had short term and was taken away from her for getting into trouble. Andrew described a reason for being in trouble with the phone was using during class when she was not supposed to be. He noted that other than some minor trouble, Lori was a good child. Andrew stated that Lori and her mom did not speak a lot but when they did communicate it was usually by email from her school computer. He also noted that when Lori had things come up that dealt with her mother (Maranda), Lori would have issues. He noted one instance where Lori came home after school and said that Maranda had called the school to talk to Lori. Lori stated to Andrew that she felt suicidal. Andrew spoke to Lori after the incident. He spoke about when Maranda showed up to the house on 5/25/23 and there was an argument. Andrew stated Lori told Maranda that she did not feel loved or seen. He also noted Maranda recorded the encounter. After this, Lori was pacing in the room back and forth asking why her mother did not love her. He stated Lori was "off" after Maranda showed up. Andrew was asked if Lori ever showed any interest in firearms or had any access to one. He

stated she showed no interest and that he kept his secured from her and it was still accounted for. Andrew was asked if there were any medications from the residence that were missing after Lori left and he stated there was none that he knew of.

Andrew stated the first time Lori ran away Maranda found out. When they spoke on the phone, and he confirmed this Maranda stated, "well you daughters probably dead so just let me know" and hung up the phone. Andrew was confused and shocked by the statement. When Lori was recovered, he spoke with Lori about running away and she couldn't do so. He also noted that Lori had tried to light a fire on/near a bus stop and was in trouble for it around this time.

Andrew noted that he had to go to Brooklyn Paige (Maranda's mother) to get Lori's social security number because Maranda would not give it to him. He noted Maranda did not want him talking Brooklyn because of some issues, but she helped him with Lori. He stated Lori liked her grandmother (Brooklyn) and was close with him. Andrew's only guess as to where Lori could be was with Maranda. He stated Maranda knew where he stayed and knew he worked nights, and believed she could be capable of getting Lori. Lori only went with Maranda once or twice while she lived in Tallahassee.

Det. Megna explained that at this time, the Violent Crimes (Homicide) Unit was now a part of the investigation in the case. He briefly explained that the probability in this case of Lori being located was not great. As he spoke about this, Andrew did not appear to be sad or concerned, his demeanor remained the same. Andrew was asked if he had anything to do with her disappearance or hurting her, which he denied. Again, his demeanor remained the same. Andrew was asked if Lori ever went walking in a specific place or enjoyed going anywhere. He was unaware of any of the places she could go and noted that he worked night shift hours.

Andrew showed Detectives the room that he had set aside for Lori. The room had office space stuff set up at the time and all of Lori's clothing in the large closet. He did not have any of Lori's toothbrushes or hairbrushes. All her clothing was still in bags however, given the setup of the rest of Andrews' residence, this did not seem out of the ordinary. The bags he emptied of Lori's clothes were large in volume. Detectives collected a pair of purple croc shoes and some clothing of Loris'.

When asked again about people Lori may have known in the neighborhood, Andrew noted a man named Terry with a purple Dodge Charger. He stated Terry used to

“look out” for Lori and knew he worked nights. Andrew was shown photos of two sex offenders that lived near him but did not recognize them. He then stated there was one he may have recognized but was unsure. The offender was Joshua Johnson (2100 Continental Ave Apt. 2).

Andrew provided information about his girlfriend, Symone Robinson. He also agreed to provide Detectives with a buccal swab. This concluded the interview with Andrew.

On 02/01/2024, Det. Megna and Det. Drake interviewed Terry Smith, a neighbor of Lori Paige and Andrew Wiley whom Wiley stated “looked after” Wiley’s home when Paige was home alone, and Wiley was at work. Smith resided directly across from Wiley’s home at the time. Smith advised he would occasionally talk to Andrew Wiley when they crossed paths. Wiley would tell him if he was working that night if they ran into each other. Smith advised he keeps an eye out anyway because he has two children. He said it was easy to see vehicles or people out of place because their cul-de-sac was tucked away. Smith said Lori always seemed “lost” because she was never with other children and wore baggy clothes which made him think she was not comfortable in her skin.

Smith said he did one time see Lori with two kids (a boy and a girl) but they were just standing in the front of the neighborhood. Smith said he told Wiley about it.

Smith said Andrew Wiley did not really know what he was doing since Lori just appeared around a year before. Smith said Wiley took Lori’s phone because she was looking at something she was not supposed to. When pressed, he said “maybe porn?” Smith did not have any direct knowledge of this and only expressed what Wiley had told him.

On 2/1/24 follow-up investigation was conducted on a lead generated from social media website, Reddit, where user Christmas850 said there was a rumor Lori was being “groomed” by a man in his 20’s. As this was a new rumor, efforts to locate and identify the user was conducted. Investigative research identified the poster as a teacher at Griffin named Christen Ellrich. Ellrich was promptly interviewed at Griffin Middle School.

Ellrich advised she heard this rumor from someone, but she could not remember from whom. Ellrich suggested speaking with Mr. Stokey, another teacher.

Mr. Stokey was determined to be a 6th grade language arts teacher who never taught Lori. Mr. Stokey said he never heard this rumor, but he could see Lori being groomed because she was much more interested in talking with teachers and adults rather than other students. Mr. Stokey brought up an incident where Lori had to see the guidance counselor because she was openly flirting and attempting to hug a teacher, Mr. Nathan George. Mr. George reported this to guidance. After Lori was spoken to, she submitted a letter to Mr. George saying, "Do you like me? Yes No." At this time, Lori was spoken to (she denied everything including the letter) and removed from the classroom to a different teacher.

Mr. Woods, a counselor at Griffin Middle School said Lori was quiet until the last month of school when she started to "spazz out" on the other students. All the teachers agreed that Lori was usually good at ignoring students' comments but had become reactive in the last month before school let out.

Donaldson Pierre, who had harbored Lori in the past, was interviewed at Griffin Middle School on 2/1/24. Donaldson said that Lori had told him that she had an argument with her dad prior to running away the first time. Donaldson believed Lori threatened to hit her dad or he threatened to hit her. He could not remember which. Donaldson said Lori told him her dad hit her, but he never saw bruises except the beginning of the school year when she had a bruise on her lip. He did not know what that was from. Lori had mentioned to Pierre her wanting to go live with her grandmother in Georgia. There is no grandmother we know of in Georgia. Lori always walked towards home from the bus stop, and he did not recall any time that Lori had missed the bus purposefully or tried to walk home.

Pierre reported he was in Miami at his grandmother's house for the summer when Lori went missing. He has also moved and said Lori would have no way of contacting him.

Griffin Middle School student, Travieon Williams, was reported to have a "flirty" relationship with Lori Paige. Williams was very stoic and claimed he and Lori were just friends who rode the bus together. Williams said he and Lori never hung out outside of school. Williams denied ever sneaking out or Lori ever sneaking out to see him.

On 2/1/24, this case was reassigned to Det. S. Childers and Det. Jerry Megna was assigned as co-case agent.

Search warrants were obtained in this case for Maranda White's following social media accounts:

The search warrants were signed by Judge M. Richardson and Judge A. Aikens and provided to the respective companies on 2/1/24. A copy of the search warrant and returns were uploaded via LRMS and provided to the clerk's office.

Upon reviewing the results of Maranda White's social media no relevant information to this case was discovered. Maranda White did use social media to speak about Lori being missing and to communicate with others about it but never anything alluding to having possession of Lori or being involved in her disappearance.

On 2/2/24, sex offender checks were conducted within a half-mile radius of 1229 Continental Ave by Detectives of the Special Victims Unit and Violent Crimes Unit. A complete re-canvass of the area with some residents even allowing officers to inspect the inside of their homes. No signs of Lori Paige were discovered.

On 2/3/24, a review of the [REDACTED] report of Lori Paige's phone was conducted. An additional email for Paige was discovered as being lori.paige1@icloud.com (password 0414) for an Apple ID. A search warrant was conducted for this account, signed by Judge M. Richardson, and provided to Apple on 2/7/24. No photos of Lori Paige appeared to be on the phone. Only three photos were viewable that appeared to be taken by the user of the phone but appeared to be that over two toddlers (possibly family members). The rest of the phone images or videos were downloaded/internet photos. There were no pictures of her belongings. On 2/26/24, Apple results were received which yielded no new information except for iCloud logs on 2/2/24 and 1/24/24 which were determined to be someone using the Find My iPhone application to locate this phone. The IP results (216.212.242.141) returned to an address in Thomasville, GA for CNSNEXT. Subpoena results showed

this information returned to Andrew Wiley at 2025 E Pinetree Blvd. Apt. 4A
Thomasville, GA 31792.

Additional accounts were located through datamining with the possibility of being Lori's just based on the username being similar:

- Roblox username: potato3140
4052178865
- Reddit: potato3140
- Instagram: potato3140
- Snapchat: potato3140 (the account was noted to have Arabic writing with the name)

A subpoena was sent to Roblox with the above username/ID but results for IP logins indicated the user never logged in in Florida. Further, the login dates from other states occurred on dates Lori was known to be in Florida.

A subpoena was sent to Reddit for "potato3140" on 2/6/24. On 3/14/24, results received showed the account was active in England with the email connorwmadden@live.com attached to the account. There is nothing to indicate this account was used by Lori.

A subpoena was sent to Instagram for "potato3140" on 2/6/24. The results from Instagram which showed the account was activated on 10/11/2019 in Houston, Texas. The email listed to the account was yayom@wmail2.com. The account shows no posts, followers, following or photos. There is nothing to indicate this account was used by Lori.

A subpoena was sent to Snapchat for "potato3140" on 2/6/24. The results from Snapchat show the account was activated on 12/15/2020 in Saudi Arabia. The account has not been used since that date and had no additional information. Therefore, this account did not belong to Lori.

On 2/5/24, Det. Megna and Det Childers contacted Pearlie Randolph Hall at 2502 Holton Street, Tallahassee FL. Pearlie advised he is the biological great-grandfather of Lori Paige. Pearlie stated he had not seen Lori Paige [REDACTED] when she was four years old. Pearlie knew that Maranda White had tried to let Lori stay with multiple people in the family. Pearlie advised that from his time with Lori when she was smaller, Lori was very smart and able to read very young. Pearlie was shown Lori's missing person flyer and advised he did not see her, he stated he wouldn't be able to recognize Lori if she walked by him right now because it had been so long. Pearlie talks to Brooklyn Paige but has not talked much to Maranda White since she moved to Tennessee.

On 2/5/24, Det. Megna and Det. Childers contacted Brooklyn Paige at 1332 Arkansas Street. Brooklyn advised she had not seen Lori since her disappearance. She stated that Lori would be allowed to come over from time to time to visit to help Andrew Wiley. She did not know Lori had been living in Tallahassee for months until Andrew Wiley came over to tell her that Lori was missing (incident reported on 5/8/24). Brooklyn Paige stated Andrew told her that Maranda White would be mad that he came over because he/Lori was not to have any contact with Brooklyn Paige. Brooklyn Paige explained her and Maranda's history at length which is summarized as follows:

Maranda had Lori at 17 years old and had asked to have an abortion at six-months pregnant. Maranda had eventually moved to Tampa and Brooklyn later moved with her to help with Lori. During that time, Maranda would sleep until 2:30 in the afternoon and leave out snacks for Lori on low shelves for her to eat. Brooklyn would confront Maranda that this was not acceptable behavior for caring for a child which led to conflict. Maranda would often leave to go have fun with friends until the early morning and leave Brooklyn to take care of Lori. Brooklyn explained to Maranda she could no longer be the caretaker for Lori and eventually left. Maranda would often complain to Brooklyn that Lori was being too talkative and that she did not have the needed level of patience for it. Brooklyn stated this was confusing because Maranda did well with other peoples' children (teaching) but struggled with Lori. Over time their relationship deteriorated resulting in them no longer speaking and Maranda telling everyone not to talk to her. Brooklyn did mention that a few years ago she had been a temporary guardian for Lori for a few weeks. Initially, Lori was on a medication and ran out of the house screaming. Brooklyn tried to chase her down the street, but Lori was screaming and drawing attention. After calming Lori down and getting her back to the house, Brooklyn became concerned about the medication she was on. Brooklyn weaned Lori off the medicine over the course of three days and stated that she did not believe Lori needed it, but rather that Maranda was medicating her unnecessarily to make Lori calmer. Brooklyn noted that Lori was extremely self-sufficient and smart. Lori was able to read before age 4 and was able to utilize a microwave on her own. She did state that Lori did lie and when caught, she would continue with the lie for as long as possible. Brooklyn did know Lori was not fond of most of Maranda's significant others but did like Maurice Jones. She stated it would not be surprising if Maranda had taken Lori to a friend's and asked them to watch Lori and not tell anyone. Brooklyn stated Lori felt abandoned by Maranda and that Lori described an incident to her where Lori received a call in the middle of class and had to go to the front of the classroom to take the call (school phone). Maranda then spoke to Lori saying she loved her but was leaving her in Tallahassee to get her. Lori was upset but did not want her classmates to see her crying, so she did not say anything and hung up the phone. When asked if Lori was capable of self-harm, Brooklyn stated "yes". She also noted that Lori had once watched Maranda attempt suicide using pills.

Brooklyn Paige stated she lived alone during the time that Lori went missing. She stated she did not believe Lori ever met her neighbor Jody Werner (known Sexual Predator). Brooklyn Paige gave accounts of suspicious vehicles driving past her home. These leads were followed-up with no results related to this case.

On 2/5/24, Det. Megna and Det. Samantha Childers contacted Layla Ogendenbe at [REDACTED]

[REDACTED] Krystal Alson was present for the interview and a teacher at the school. Layla and Krystal both reside at [REDACTED]

Layla described Lori as being extremely quiet and smart. She stated Lori enjoyed school, but that Lori mentioned missing her friends in Nashville school. She last saw Lori on the last day of school and knew that Lori had intended to attend Griffin next year. She did have Lori's number but only remembered her texting twice. She stated Lori did not really use social media and kept to herself. Lori did not talk much about her parents, but she (Layla) heard from Aden who heard from other friends that her dad was mean to her. Layla did describe Lori's backpack as a rainbow tie-dye Jan sport back-pack. She noted that Lori used to keep a small black digital clock in it that she would bring out during class (set it on her desk). She knew that Lori was friend with Aden Diaz (Layla's boyfriend). She did note that Lori may have had a crush on Aden. Layla was unaware of Lori talking to anyone else or outside of school. She did note that Lori was close friends with Anna Lilly Gomez. Layla did state that she had a picture of Lori from the last day of school and provided it to me via text message. I provided her my TPD business card and asked her to share my number with any of her friends to see if anyone had additional pictures of Lori. She stated she would.

On 2/5/24, Det. Megna and Det. Samantha Childers contacted Aden Diaz (truant classmate of Lori Paige) at his residence. Aden could not provide his phone number because the phone was WiFi only and he could not look up the number due to the phone being stolen. Aden stated he only knew Lori from Art Club, he only talked to her during Art Club, and he did not hang out with her. He thought he had her as a friend on Instagram at one point but could not remember the name of the account and was unable to locate it on his Instagram account. Aden stated he never talked to her about his home life. Aden stated he knew Lori watched anime.

On 2/5/24, additional SVU Detectives assisted with interviewing Lori's former classmates/friends. Some of the interviews were follow-up interviews of already-known friends. Additionally, Griffin Middle School made announcements over the intercom asking for anyone to come forward if they knew information and speak to Detectives of the Special Victims Unit and Violent Crimes Unit:

The following narrative was completed by Det. Osborn:

On /05/2024, I conducted multiple interviews with students at Griffin Middle School located at 800 Alabama St. in reference to the missing person investigation of Lori Paige. The interviews were as follows:

Information: I asked Grimsley about prior information he provided about seeing Paige, whom he described as a friend he had known since 6th grade. Grimsley previously stated she saw Paige a Family Dollar in Tallahassee. I asked Grimsely about the certainty it was Paige and she stated he was 50-60% sure it was Paige. Grimsely spoke with the person he believed was Paige, and she stated she had moved, but did not say where. Additionally, Grimsely asked if she knew she was a missing person and the female stated she did not know. When asked about the location where this happened, Grimsely described the Family Dollar located at 2526 S Monroe St. The person Grimsely believed was Paige was alone and he described her as wearing a black baseball style hat and tan pants. Grimsely stated Paige had an Instagram account and TikTok account, though he only knew this because he saw her looking at the pages on her phone during class.

Martinez stated Paige played a basketball game and Friday Night Funkin. Martinez stated Paige mostly played the game on a computer.

Upon research of the game, I found Friday Night Funkin is an open-source game that can be freely downloaded. Based on brief research, it does not appear there is a login requirement for the game. – End of Det. Osborn's report.

The following narrative was completed by Detective TiBria Howard:

On February 5, 2024, while working as a detective with the Special Victims Unit, I was tasked with assisting detectives with interviewing juveniles at Griffin Middle in reference to missing 12-year-old, Lori Paige.

I spoke with, Peilyn Tillman (7TH Grade), who identified herself as being friends with Lori. Peilyn explained she would say "hi" to Lori in passing or comment about how her hair look nice. Peilyn further explained Lori was quiet and didn't talk about her

personal life or family. Peilyn stated she believe Lori have an Instagram account but was unsure of the username. Peilyn stated Lori's main friends were Tory and Laniyah. Peilyn stated kids at school would call Lori weird because she would mix her food together.

Peilyn informed me she heard a rumor that Lori was in a suitcase or bag behind the airport. Peilyn stated she heard of this rumor during "Girl Circle" that meet every Wednesday at Griffin Middle. Peilyn stated she heard another rumor that someone saw Lori walking in an unknown area, wearing unknown clothing. Peilyn could only say that Lori was no longer in possession of her bookbag.

I next spoke with Jakyiah Johnson (8th Grade). Jakyiah expressed really missing Lori who she identified as her bestfriend. Jakyiah stated she and Lori had Spanish class together. [REDACTED]

Jakyiah stated when Lori didn't return to school, she became worried and asked Mrs. Summers where Lori was. Jakyiah explained she last saw Lori right before the summer at school. During that time Jakyiah stated Lori was in possession of two bookbags, one purple and black containing her schoolwork and the other one pink in color containing clothing.

Jakyiah described Lori as quiet majority of the time and would usually sit with her (Jakyiah), China, and DeAndre. Jakyiah believes Lori possibly had a crush on DeAndre due to her always sitting next to him and laughed at all his jokes. Jakyiah proceeded by informing me Lori had an Instagram under the username, @lori_paige. Jakyiah stated Lori would use the Instagram page to watch videos.

Jakyiah expressed missing Lori and wanting her to come home safe. Jakyiah explained she was worried due to the last time Lori went missing she returned the next day and this time she has been missing for several months.

The following narrative was completed by Detective Zweydorff:

On 2/5/2024, I Det. Zweydorff with the Tallahassee Police Department Special Victim’s Unit responded to Griffin Middle school to speak with various students in reference to this case.

I spoke with student, Jazmine Moody, who advised the following:

Moody and Lori Paige (LP) had gym class together in the 6th grade. Moody and LP barely spoke, but when they would it would only be during that gym class and would not be concerning anything personal. Moody noticed two boys who would speak with LP during that class. These boys would often challenge LP to a footrace during gym class. Moody did not know these boys’ names. When asked about LP’s social media accounts, Moody believed LP had Tik Tok and Instagram. When asked how she knew about these accounts, she stated she only believed LP had them because, “everyone does”. The last time Moody saw LP was at school, she thinks LP was waiting for her bus to go home.

I spoke with student, Anisten Kierce, who advised the following:

Kierce lives in the same area as LP, and they rode the same bus to school. Both LP and Kierce shared the same bus stop. After LP had run away the first time, her father has seen her walking with a boy he had told her not to walk with. While at the bus stop one morning, LP’s father walked up to the bus stop with a belt in his hand. He pulled LP off to the side and yelled at her, while giving her a “whooping” with the belt. Kierce stated she did not see where LP’s father struck her with the belt and what was said during the “whooping”. Towards the middle of school year, LP, Kierce and a few other children were waiting at the bus stop to go to school,

when LP told everyone she, “Can’t take this abuse”. Everyone at the bus stop laughed and the conversation about abuse ended. No details about the abuse were ever mentioned.

Kierce believed LP had 3 girlfriends, who were the closest to her. Kierce did not know any of the three girls’ information. Kierce knew LP played Minecraft but believed she played it on the school computer.

I spoke with student, Anallely Gomez, who advised the following:

Gomez and LP had math class together last year in the 6th grade. Gomez and LP would often talk about math, as LP would offer to help Gomez because she was struggling in the class. Gomez and LP did not speak about anything personal and did not talk outside of the classroom. They did not have each other on social media, or each other’s phone numbers. The last time Gomez saw LP was the last day of school for the 6th grade during math class.

The following narrative was completed by Detective Curtis Bridges:

On February 5, 2024, I assisted with interviewing potential witnesses and friends of Lori Paige at Griffin Middle School. I had the opportunity to speak with Zi’yanna Gully regarding Paige being missing. Gully is in the seventh grade at Griffin Middle School. When asked Gully stated the last time, she saw Paige was on the last day of school in the previous school year in 2023. Gully explained she observed Paige walking near the school. Although Gully did not know Paige well, Gully did describe Paige as acting weird and funny. According to Gully, she did not know any social media platforms besides Paige's Instagram account. Gully did not know the screen name Paige would have used. Gully also stated she overheard Paige saying she wanted to leave the school. Gully did not know anything further about Paige. – End of Det. Bridges report.

The following narrative was completed by Detective Collins:

On February 5, 2024, while assigned to the Tallahassee Police Department's Violent Crimes Unit, I was asked to assist with a missing persons investigation. I was tasked with going to Griffin Middle School and assisting with interviews of juveniles who may have known the missing person, Lori Paige.

While at Griffin Middle School I interviewed Kaidyn James and Lynyiah Clay. [REDACTED]

Clay advised she lived near Paige and had the same school bus stop as her. Clay would interact with Paige at the bus stop before and after school and advised she did play with her outside of school occasionally. Clay was unfamiliar with Paige's whereabouts or who she may be with. Clay could not advise if Paige was adventurous by nature but did say she enjoyed being outside. I asked Clay if there were ever any suspicious older men who approached them or made them feel uncomfortable, and she could not recall any. Clay advised she has an Instagram account but was not friends with Paige on Instagram. Clay could not provide any further information of note.

James said she only knew Paige from school and had some classes with her. James would commonly sit with Paige when she was happy and ask her what was wrong when she was sad. James advised Paige claimed she was being abused at home and described her as having scrapes to her knees and elbows at times and possibly a busted lip. James recalled Paige being scared to go home one day as she had gotten in trouble at school and discussed running away. James later heard Paige had run away but based on her explanation of events after the fact, this is believed to have been the previous time Paige left home. James heard a rumor that Paige's body was recovered near the airport in a bag but could not recall who she heard this information from. James advised she had not seen or heard from Paige since school ended the previous year. – End of Det. Collin's report.

The following narrative was completed by Detective Rabaglia:

On 02/05/2024, as a Detective with the Special Victims Unit, I was tasked with speaking with students at Griffin Middle School located at 800 Alabama Street in reference to missing juvenile, Lori Paige.

I contacted a female student, later identified as Kamora Jeff, who advised she had not seen Paige since 6th grade. Kamora stated Lori was a quiet individual who had very few friends. She couldn't provide any of Lori's friend's names. Kamora said she had heard from another student, Paylin Tillman that an ESE teacher, Summers had said she knew where Lori was and that she was safe. It was also said Summers keeps in contact with Lori. Det. Howard later spoke with Paylin. Please see her supplement for further. Kamora stated she did not know of any social media accounts for Lori. Kamora also advised she did not know if Lori was involved in any extracurricular activities at the school.

I also spoke with another female student, later identified as Paris Roquemore, who advised she and Lori had 2nd and 6th period together in 6th grade. Paris said Lori only spoke with one person in each of her classes. Paris mentioned an incident after the first time Lori ran away from home a group of students were talking about it in which Lori could overhear them. Paris advised a few days after this Lori went missing. Paris said a couple of times before when Lori would run away, she would return. Paris advised there was a rumor going around the school that Lori had gotten kidnapped and killed then put into the back of a van.

When asked if she heard how Lori was killed Paris couldn't say. Paris advised there were rumors all over Instagram. Paris said students came to her and told her she knew Lori was killed and kidnapped then put into a plastic bag in a trunk. Paris advised she asked "Mrs. Summers" who is a teacher at the school. Paris said Summers said she didn't think that was true.

Paris stated she and Lori weren't friends, but they knew a little bit about each other. Paris advised they began talking when they were paired up in class. Paris said they never spoke about personal issues, but she could tell when Lori was having a bad day.

Paris advised when something was wrong with Lori as she would keep her head down in class and not talk. Paris also said Lori wouldn't do any work in class which was unlike her. Paris said she thought Lori walked to and from school and she did not participate in extracurricular activities.

I asked Paris if Lori ever told her where she would go when she had run away in the past. Paris stated Lori told her she would walk away to “get a break” but did not know where. Paris did not know of any issues Lori might have had at home. I asked Paris if Lori ever hung out anywhere outside of school. Paris said she used to go to the Dade Street Community Center (Lawrence-Gregory Community Center) located at 1115 Dade Street.

Paris was not sure if Lori had any social media accounts, but she knew she had a phone. Paris advised Lori had a crush on a boy while in 6th grade, but she did not know his name. Paris mentioned Lori told her she liked to walk around outside and watch videos on YouTube. I asked Paris if Lori had any friends in her neighborhood, but Paris did not know where she lived.

Paris advised Lori used to hang out with another student possibly named “Christiana”. Paris did not know her last name but advised they had 2nd period together last school year. Paris said she heard from other students there was a rumor that “Christiana” was raped and possibly impregnated by either her uncle, dad, or stepdad. Paris said a few weeks after the rumors started about “Christiana” she did not return to school. Paris was unsure if she switched schools last school year. When I spoke with school staff, they advised they did not have a student by that name. I utilized law enforcement databases and was unable to locate an incident involving the name Paris provided.

The following is Paris’s mother’s information: Kimberly Roquemoire (850-443-8403).

The incident was captured via my Body Worn Axon Camera. This concluded my involvement with this incident. – End of Det. Rabaglia’s report.

The following narrative was completed by Detective Taylor:

On February 5th, 2024, I responded to [REDACTED] to attempt to locate any leads for the missing person case of Lori Paige. One student that was believed to be friends with Lori was [REDACTED] was called to the School Resource Deputy office to be interviewed. [REDACTED] provided [REDACTED]

[REDACTED] knew he was being called to answer questions related to Lori Paige. [REDACTED] stated he shared a bus stop with Lori and was in science class with her. [REDACTED]

stated after Lori ran away the first time, she told him that she was staying on pool furniture at a nearby complex. [REDACTED] remembered being at the bus stop with Lori when a white truck approached the bus stop and ordered Lori to the truck. [REDACTED] believed the truck was driven by Paige's uncle but did not hear any further. [REDACTED] saw Lori at school later when the bus got there. [REDACTED] stated he saw Lori talking with a Detective and believed this was when Lori was recovered the first time.

[REDACTED] stated Lori talked to several other kids to include Jada Cash. Cash would tell [REDACTED] that Lori did not have a good relationship with her parents especially her mom. Cash moved to Orlando after the school year and the only other information [REDACTED] had for Cash was her Instagram name - m0re.luv4_jayy. I spoke with the school front desk who provided the following information:

The other friends mentioned were Peliyn Tillman, Travian Williams, Lynyiah Clay, and Karmia (not further identified). I was not able to identify Karmia but the other three were interviewed by Detectives while at the school, please see their supplements for more information.

[REDACTED] stated he heard that Lori's mother came to town after Lori was reported missing most recently and that Mrs. Summers was the one who told [REDACTED] did not have any additional information.

I spoke with front desk and asked about former student Diamond Ivey and was given the following information.

A search warrant was obtained for Instagram account "lori_paige" and provided to Instagram on 2/7/24. Results were received on 2/12/24 which showed the account

was created in 2012 (when Lori would have been a year old). This account does not appear to belong to Lori.

On 2/5/24, Det. Megna and Det. Samantha Childers contacted Antwan Wiley at Tallahassee Public Works on 2727 Municipal Way, Tallahassee FL. Antwan advised that Lori was extremely shy and quiet and that when she would visit, she would mostly just sit and watch tv on the couch. Lori would come over to visit once a month with Antwan's family (wife/children) and once or twice on trips out of town. He stated Lori would be excited while she was out of town but sad as soon as they returned. Antwan Wiley expressed that Andrew Wiley was trying to do more to make Lori happy but that she always seemed quiet. He stated Lori did not want to return home with Maranda White and that she was not fond of Maranda's wife, Latonya White. He did note that he had caught Lori watching anime pornography and knew Andrew Wiley to have caught her watching the same type of pornography in a previous incident. Antwan Wiley believed [REDACTED] before she came to stay with Andrew Wiley when they lived in Miami, FL.

Antwan Wiley did recall seeing Lori one time walking around the streets near her residence on Continental Ave and he thought she was hanging out with friends where she wasn't supposed to be. He recalled being in a truck when he saw her and called her over telling her to go home. He later learned from Andrew Wiley this was her normal pattern when she was allowed to walk home. Antwan Wiley also advised that Andrew Wiley had a son approx. one year older than Lori, whom Lori has never met. Andrew Wiley had not been a part of raising his son. Antwan Wiley as well as his son's current custodial parents confirmed Lori Paige and Andrew Wiley's son have not met nor would they ever communicate.

On 2/6/24, Det. Megna and Det. Samantha Childers drove to 890 NE Washington Ave, Lake City FL. This address was previously listed for La'Tonya White (Maranda's wife) and it was known that Maranda White visited Lake City after Lori's disappearance. There Marsha Allen (mother of La'Tonya) was contacted. Marsha Allen stated that she had met Lori three years ago when she, Maranda and La'Tonya came to visit. She stated this was the last time she saw Lori. She initially stated that Lori was nice and "minded" Maranda well. When asked questions about Maranda and Lori, Marsha Allen stated she did not really talk to Maranda and that La'Tonya stayed out of Maranda and Lori's situation. As we spoke with her and showed her Lori's missing juvenile flyer, Marsha then paused and pointed at the paper stating,

“that’s a bad girl”. Marsha Allen advised La’Toyna told her that Lori did not listen and wanted to do whatever she wanted. La’Tonya conveyed that Lori wanted to live with her dad because she was allowed to do whatever she wanted there. Marsha Allen was adamant that La’Tonya stayed out of things between Lori and Maranda. The house Marsha Allen lived in was smaller and it appeared only Marsha Allen was staying there. Marsha Allen could not remember if Maranda/La’Tonya had visited since Lori’s disappearance except for one time in January 2024 to attend her retirement party. She stated they always stayed with her when they visited or possibly at a hotel (could not recall the names of the hotel).

On 2/7/24, Det. Zweydorff contacted Daisy Garcia (reported Godmother of Lori by Maranda). Detective Zweydorff reported the following:

On 2/7/2024, I was tasked with locating Daisy Garcia. Garcia was known to be a potential godmother for Lori Paige and living somewhere in the Tallahassee area. █

█ I called the active number 850-339-4141 and was sent to voicemail. I left a message explaining my need to speak with Garcia. Later that same evening I received a phone call back from Garcia from the same number I had attempted contact with earlier. Garcia advised she and Maranda knew one another for quite some time, because Garcia’s son, Brandon Herrero and Maranda were in the same FSU STEM program together. Garcia advised she knew Maranda had a troubled upbringing, but only had information Maranda had told her. Maranda would tell Garcia about her mother, Brooklyn, and how she would bring home “dates”. Brooklyn would then expect Maranda to “date” the men she brought home. I attempted to clarify with Garcia about the word “date” and if it meant more than dating but actual sex. Garcia did not know, as Maranda never went into detail about the “dates”.

The last time Garcia saw Maranda and/or Lori was in the summer of 2021. Garcia was able to review text messages between she and Maranda and confirm the last date was June 7, 2021. This visit is when Maranda brought Lori to live with Andrew. The visit was normal according to Garcia and remembered Maranda using her Wi-Fi to use zoom, for her “white coat” or medical school interview. Garcia never spoke with Lori outside of this visit. Garcia did not have a phone number for Lori, nor any type of social media profiles. Maranda told Daisy she would be leaving Daisy’s

phone number with Andrew in case he needed to reach out with help for LP. Daisy said she never heard from Andrew at any point.

Garcia provided me with text messages she received from Maranda before and after Lori's disappearance. The screenshots of text messages are messages received by Daisy from Maranda. The conversation was dated March 2. Those messages are dictated below:

"Daisy I need you"- Maranda

"What's up?"- Daisy

"Lori;s dad won't let me talk to her

Her dad let her go with my mom

I explicitly told him not to and he did

I explained to him why she is an unsafe adult and I have given him alternatives" – Maranda

"What does the paper work say?" – Daisy

"50/50 but im the custodial parent"- Maranda

"How long does she have her for?"- Daisy

Shes been there 10 months I believe"- Maranda

"No how long does she have Lori for?"- Daisy

"Brooklyn? Idk I didn't ask because I was just listening to the details. They're manipulating her and I was just trying to hear what she was told" – Maranda

"Why did he do that?"- Daisy

"To spite t Me" – Maranda

"Because I expressly told him not to on multiple occasions

They both hate me and are willing to use my child as a pawn"- Maranda

Maranda then sends Daisy screenshots of messages between Maranda and Andrew.

“On the very few occasions that you called to talk to Lori I gave her the phone no problems. I do not understand why you choose not to do at least that much for me. I’m her mother and I would like to speak to Lori.”- Maranda

“I also paid child support. Tell me what have you done for the past 10 months besides call twice?

I also never said no. You just don’t call. Stop asking and just call”- Andrew

“Will do.”- Maranda

“You wouldn’t even give me her social security number. Stop acting like I have to do anything for you. I just do it because I ain’t spiteful like you. But that’s fine because from now on everything you won’t help me with, your mom will. Im done going back and forth with you. She is extremely happy over here. Don’t make things difficult for us.” – Andrew

“If you involve Brooklyn, expect to have a case opened because I will 100% call CPS on you. Brooklyn Paige is an unsafe adult and is to have no contact with Lori. - Maranda

“I’m glad she’s happy, that’s all I’ve ever wanted for her. I want her to be where she is happy bu the minute you involve Brooklyn you are putting her in danger and I will have to intervene.” – Maranda

“STOP RUINING YOUR DAUGHTERS LIFE!!!! SHE DOES NOT WANT TO GO BACK AND LIVE WITH YOU!!! OPEN THE CASE BECAUSE SHE IS DOWN HERE IS YOU COULDN’T TAKE CARE OF HER AND SHE TOLD YOU FROM HER MOUTH THAT SHE DOES NOT FEEL SAFE AROUND YOU. THIS CONVO IS OVER. DO WHAT YOU GOTTA DO *PEACE SIGN*”- Andrew

“Will do. You talk in capital letters like you didn’t rape a 16 year old. But you’re not ready to have that conversation”- Maranda

The conversation then shifts back to Maranda texting with Daisy. Maranda is the gray text bubbles and Daisy is the blue text bubbles.

“Oh I thought maybe he needed help because he had to go out of town for work or something...not spite” – Daisy

“He could have taken her to you though. Or Jessica” - Maranda

which yielded no significant leads to Lori Paige's location. Furthermore, orders were sought to establish communication patterns and location data for Jones during the time of Lori Paige's disappearance and for the times before and after. No significant leads developed, and Jones was certainly in Tampa, FL at the time Paige was thought to have first gone missing.

On 2/8/24, a large-scale grid search was conducted initially branching out from Lori's address (1229 Continental) by over 50 TPD officers. The span of the area covered approximately 5 square miles, which included businesses in the area with active video surveillance, wooded areas, bodies of water and residences. No leads were developed from this search.

Canvasses also were conducted with the help of civilian community members and thousands of missing person fliers were disseminated throughout the area on multiple occasions. Tips generated from these canvasses (whether plausible or not) were followed-up with and no significant leads were developed.

On 2/12/24, members of the TPD and four K9 cadaver scent dog teams conducted a search of the area from behind the residence to San Louis Park, including from West Tennessee Street to the west entrance of San Luis Park with negative results. There was one area a dog showed "interest in" but did not alert. This location was by the bridge of the lake at San Louis Park near an area with large palm trees and turtles approx. one quarter of the way down the bridge if you are coming from the bathroom area. The area was checked due to the low water and being able to walk around the area, but it was met with negative results.

On 2/13/24, the Leon County Sherriff's Office Dive Team conducted a search of the lake at San Luis Park with negative results.

On 2/14/24, TPD had a report of a kidnapped juvenile (black female) who reported to a friend via social media that she was abducted by a male in a vehicle and being held in a shed. During the investigation, the juvenile was located that day and it was learned she lied and there was no abduction. It was noted during the investigation that the juvenile was living two houses down from Brooklyn Paige's residence at the time.

On 2/14/24, a nationwide Teletype message was sent with the following: “The Tallahassee Police Department has a missing 12-year-old black female with black dread lock style hair, brown eyes, approx. 5’0 tall, 120 pounds and a tie dye rainbow Jansport backpack. She has been missing since 06/02/2023. We are asking any agency that has had contact with, located or has unidentified remains matching the above description of Lori Paige since 06/02/2023 please contact them at 850-891-4200.”

On 2/14/24, Detectives Megna and Roberts traveled to Nashville, TN to contact Maranda and Latonya White to further investigate the disappearance of Lori Paige. Nashville Police Dept Liaison Detective Keith Sutherland (FBI-TFO) assisted with this portion of the investigation:

Detectives Roberts and Megna arrived in Nashville, TN on the evening of 2/14/24. At 6:00pm on 2/14/24, Roberts and Megna conducted covert surveillance on the residence of Maranda and Latonya White located at 1720 Windover Dr, Nashville, TN. Surveillance began during daylight hours (6pm) and concluded after 8:30pm. Lori Paige was not seen at the residence.

On 2/15/24 and after contacting Det Sutherland (Nashville PD), Detectives Roberts, Megna and Sutherland traveled to Goodlettsville, TN as it was a suburban town just North of Nashville where Lori Paige, Maranda White and Latonya White had resided from 2020 through 2023. Lori Paige attended Goodlettsville Middle Preparatory School for the 2021-2022 school year.

On 2/15/24 at 10:05am, Detectives Roberts, Megna and Sutherland arrived at Goodlettsville Middle Prep and contacted principal Dr. Michelle Demps. Dr. Demps provided information to detectives which included grades, attendance records and behavior records for Lori Paige while she attended school there. Dr. Demps also confirmed that students would have only been physically attending school in the latter half of the year due to COVID-19 protocol. Dr. Demps said Lori Paige rarely missed school and often made the Honor Roll for high grades (A’s and B’s). According to behavior records for Paige, it appeared as though there was an instance where Paige became enraged and began throwing writing utensils about the classroom in an apparent tantrum. Paige was referred to a school counselor (Dr. Webber) and ultimately referred to a School Board certified social worker. Dr. Demps provided contact information for Lisa Britt, the social worker from the School

Board assigned to Lori Paige. Contact was not made with Dr. Webber or previous teachers of Paige due to them having illness related absences at the time detectives were in Goodlettsville.

On 2/16/24 at 2:30pm, Lisa Britt arrived at the FBI Field Office in Nashville, TN to be interviewed by detectives. Britt also brought case notes from her sessions with Lori Paige as a reference. Britt explained several sessions with Paige during the last few months of the 2021-2022 school year. Some of the sessions included surveys and exercises to gauge Paige's perception of herself and her ability to cope with stress. Some of the exercises included identifying personality traits and common feelings for Paige. A consistency throughout the interview with Britt established that Paige was likely suffering from depression and had feelings of inadequacy. There was a note that indicated that Lori Paige was pondering what would happen if she died.

In an exercise where Britt provided positive and negative descriptors of personality traits or feelings, Paige often applied negative feelings and attributes toward herself and those of a positive nature outside of herself. Paige described herself in this exercise as "evil", "disrespectful", "lazy", and "hateful". Some of the negative descriptors were later attributed to Paige's mother referring to Paige as these things. It also appeared that Paige is obsessed with "Anime" according to Britt. Britt stated she spoke often about it and notes indicated her wishes to "watch all the anime in the world".

Lisa Britt confirmed Paige was hospitalized at Vanderbilt University Hospital for a behavior-related issue, but this information was provided by Maranda White. The information Britt held related to Paige's attempts to end her own life was provided by Latonya and Maranda White to Britt. Records from Vanderbilt University Hospital have been requested and are pending receipt at this time.

On 2/15/24 at approximately 11:50am, Detectives Roberts, Megna and Sutherland arrived at 7303 Preston Run in Goodlettsville, TN which is a previous residence of Maranda White, Latonya White, and Lori Paige while Paige attended school at Goodlettsville Middle Prep. Preston Run is a gated apartment complex and each apartment is an individually numbered address on Preston Run. Apartment complex management provided contact information for those tenants having lived in and around 7303 at the time Maranda White, Latonya White and Lori Paige lived there. None of the tenants remembered any disturbances or issues related to 7303. Of the

tenants who did have occasion to interact with the White's or Paige, the interaction was minimal as a cordial passing between apartments. The complex management did confirm a late history for the White's tenancy included non-payment of rent and a termination of the lease agreement in January of 2023.

On 2/15/24 at 5:30pm, Detectives Roberts, Megna and Sutherland arrived at the home of Latonya White and Maranda White. Contact with them was made with the assistance of Nashville PD patrol officers as well. The intention of the contact with the White's was to obtain a buccal standard from Maranda White for comparison to Lori Paige and entry into the CODIS system should a genealogical DNA comparison be needed. Maranda White had been reluctant to provide this sample up until this date. Her reluctance, as she expressed later, was due to her distrust for how this case was being investigated.

The second purpose for the contact with Maranda White was to obtain her cell phone which was known to contain text messages and phone calls between her and Lori Paige as well as content of messages and phone calls between her and Andrew Wiley (Lori's father). Maranda White had also expressed in a previous phone interview that her and Wiley had not gotten along, and that Maranda White felt that communication between her and Lori Paige was purposefully being thwarted by Wiley. There was also a video which Maranda White stated she had captured by her cell phone that documented an interaction between her, Lori Paige and Andrew Wiley on 5/25/23 after she traveled to Tallahassee, FL to confront Paige and Wiley at Wiley's residence (1229 Continental Ave). A search warrant for Maranda White's cell phone had been prepared with the assistance of Nashville PD but was ultimately returned as unserved due to Maranda White's cooperation during contact with her on 2/15/24. Maranda White and Latonya White also provided statements during this contact. Both statements were captured on body worn camera by Detectives Megna (Maranda White) and Roberts (Latonya White).

According to Maranda White, she gave birth to Lori Paige when she was only 17 years old. White and Andrew Wiley never had a lasting relationship, and their only connection was Lori Paige. Maranda White stated that any contact with Wiley was only for the purposes of custody and care for Lori Paige. Maranda White also

[REDACTED] and an instance where she was kicked out of Brooklyn Paige's home in Tallahassee, FL resulting in her being homeless while still having custody of a then 1-year-old Lori Paige.

Maranda White stated that when Lori Paige was approximately 4 years old, she was placed in Andrew Wiley's custody [REDACTED]

[REDACTED] This was after White's grandfather had traveled to Tampa, FL to take custody of Lori Paige due to Lori having been removed from the care of Maranda White and due to Maranda White having a mandatory mental health evaluation. At the time, Brooklyn Paige had custody of Lori Paige, but moved out of the State of Florida and could no longer care for Lori Paige. [REDACTED]

[REDACTED] From the time Lori Paige was approximately 4 years old until she was able to attend elementary school, Lori Paige was living in Miami, FL with Andrew Wiley, and Wiley's family. Custody of Lori Paige was ultimately given back to Maranda White before White moved to Nashville, TN. While in Nashville, TN, Lori Paige attended 3 different elementary schools in the area while living with Maranda White and Latonya White. During school breaks for winter and summer, Lori Paige would live with Andrew Wiley in Miami, FL and then later in Tallahassee, FL.

According to Maranda White, Lori Paige was transferred to the care of Andrew Wiley in the summer of 2022 with the intent of her returning to Nashville, TN for the 2022-2023 school year. In Late summer of 2022, Maranda White claimed that her financial assistance for school was withheld, leaving her and Latonya White struggling financially. Maranda White claimed that due to this, she was unable to afford her residential rent payments and feared Lori Paige would undergo stress over Maranda White and Latonya White being evicted from their apartment. Maranda White claimed that for this reason, she relinquished custody of Lori Paige to Andrew Wiley just before the 2022-2023 school year. She claimed to have provided all the information for Paige's enrollment into school in Tallahassee, FL to

Antwan Wiley (Andrew Wiley's brother) due to her poor relationship with Andrew Wiley. This contradicted the complex management's information that the White's lease was terminated in January of 2023. It also contradicted statements from Andrew Wiley where he claimed that Maranda White abruptly chose not to return to Tallahassee, FL to retrieve Lori Paige due to Paige's unruly behavior. Maranda White claimed that before her decision to place Lori Paige with Andrew Wiley, she sought out her ex-boyfriend, Maurice Jones, to care for Paige but he refused.

The statement provided by Latonya White corroborated that of Maranda White.

Both Latonya and Maranda White were asked about their whereabouts in and around the days of Lori Paige being reported missing on 6/3/23. Both claimed to have been in Nashville, TN and denied coming to Florida to retrieve Paige. Both denied hiding Lori Paige from Wiley or authorities and stated that they do not know where Lori Paige is. Historical location data from their cell phones corroborates this as well as location data from their vehicle information (2019 Hyundai Santa Fe TN-BDL4450 and Honda CRV SUV TN-BLS6576). There was no indication that Lori Paige was living in the home of Latonya White and Maranda White at the time of contact on 2/15/24.

Maranda White provided a buccal sample when requested which was impounded as evidence in this case. Maranda White allowed detectives to search her iPad device, which was synced and mirrored to her cell phone. White requested to keep her phone due to needing it for school and work purposes. Maranda White provided the passcode for the iPad device and consented to the extraction of all data linked to her accounts. This included the text conversations between her, Lori Paige and Andrew Wiley along with the video she took of her interaction with them on 5/25/23. Nashville PD and the local Nashville FBI office assisted in the extraction of data from White's iPad. The iPad was subsequently returned to White once the data was extracted. All pertinent text messages and videos have been uploaded as evidence in this case. During the reviewing of the video captured by Maranda White

on 5/25/23, Lori Paige appears to not wish any contact with Maranda White and is apparently angry with Maranda White's lack of interest in her. Andrew Wiley allows Maranda White to have contact with Paige unfettered but Paige is reluctant and claims she is happy living with her father. See video for context.

A historical survey of calls for service for residences related to the White's as well as any calls for service related to the White's and Lori Paige was conducted for the Nashville, TN area and with the assistance of Nashville PD. Only one documented incident was located [REDACTED]

[REDACTED] During this incident, Lori Paige was reported to have run away by Maranda White while they lived at 1004 Sunset Cir in Nashville, TN. Lori Paige, [REDACTED]

On 2/20/24, billboards were put up by the FBI/TPD requesting information about Lori and that information leading to her recovery would result in a \$15,000 reward.

On 2/20/24, over 100 officers with TPD conducted another grid search of San Luis Park but was met with negative results.

A search warrant was obtained for historical records for Andrew Wiley phone number used during the time frame from before Lori went missing to October 2023. Phone records showed the following of note results:

On 6/2/23 from 12:20 AM to 9:30 AM, the handset (cellphone location) showed consistent with Wiley's residence. However, LPR showed Wiley's vehicle (white Dodge Charger FL Tag # CNXP53) southbound at the intersection of I-10 and North Monroe at 8:28 AM.

- Just before 9:30am his handset departs, moving east (maybe Alabama St), and then south and back to the area of the residence (or south of it) around 9:40am.
- It immediately departs this area, moving east (maybe Tennessee St), north (maybe Magnolia), back west (7th), north (maybe Monroe) and then back to the residence by 10:14am. This is consistent with a LPR hit on 7th Avenue at 9:57am.
- There may have been a stop in the N. Monroe/John Knox area for a few minutes.
- A call is placed to Priceline at 2:56 PM (877-477-5807).
- The handset departs the area of the residence just after 4pm for the trip to JAX.
- The handset arrives in the area by 6:59pm and then departs around 7:20pm
- The handset appears to take I10 to I95 on the way over and then I295 to I10 on the way back.
- The handset returns the area of his residence around 9:45pm
- The handset then departs around 10:45pm and travels to work consistent with taking I10.
- On 6/3/23 the handset events starting 12:21am consistent with the area of his work.
 - It appears between 8:21am and 8:37am the handset departs work. He would be consistent with the Monticello area for the 8:37am event.
 - No additional events until just after 11:00am, which are then consistent with the residence.
 - Handset remains in this area until approximately 12:18pm when it departs traveling north.

- It arrives in the Lake Jackson area around 12:30pm and remains until approximately 3:30pm
- It then travels back to the area consistent with his residence and remains through end of day.

On 2/19/24, Detective Megna contacted Andrew Wiley by phone. Wiley agreed to meet at TPD at 9:00am on 2/20/24 for an interview. Although the purpose for the interview was not shared with Andrew Wiley, detectives had learned of historical cell phone location data for Wiley that included travel to Jacksonville, FL in the hours before Lori Paige was reported to have gone missing. It was also reported to detectives that Wiley had called in sick to work on two days (5/27/23 and 5/29/23). Wiley is the only person reported to have had contact with Lori Paige between 5/25/23 (at approximately 8pm) to the time she was reported missing.

By 2/20/24 at 9:00am, Andrew Wiley had not arrived at TPD for interview and was not responding to attempts at contact by detectives. Contact was made with Brooklyn Paige at her residence, who stated that Wiley had been to her home on 2/20/24 and expressed his concerns for being treated as a suspect in the disappearance of Lori Paige. Detectives then received notice that Wiley would appear for his interview at TPD with legal representation. Wiley arrived at TPD at approximately 2:30pm on 2/20/24. The interview was audio and video recorded.

During the interview with Wiley and his attorney, questions regarding Lori Paige's demeanor were readdressed. Wiley conveyed that Paige was happy with him and did not wish to return to Nashville with her mother. Wiley was asked about how he disciplined Lori Paige when she misbehaved. Wiley stated that he had disciplined her with a belt during one occasion and had to physically restrain her when she attempted to run away during another incident. Wiley described injuries sustained by both he and Paige during the time he had to run after her when she attempted to flee the residence while being disciplined. Wiley stated examples of Paige's misbehavior as not immediately returning home after school and lingering with classmates in the area when she was supposed to be home. Wiley also gave an example that Lori Paige learned to only exude the effort in school required to pass and no longer gave her maximum effort in her schooling. For this she was also disciplined for her falling grades, at which point Wiley took away a cell phone he had purchased for her.

Wiley went on to explain that Maranda White's lack of interest in Lori Paige was detrimental to Paige's well-being and emotional stability. He explained that Paige would be doing well emotionally until Maranda White would make contact and send Paige into depression.

When asked about friends Lori Paige had, Wiley was unable to name any and stated that she almost never spoke of friends or interests in classmates. Wiley said Lori Paige was able to prepare meals for herself and was content watching TV and had an affinity for "anime". Wiley stated that he removed her privileges using electronic devices when he caught Paige viewing "anime pornography" on his computer. This was consistent with what other family members of Lori Paige had stated about her and her obsession with "anime" and instances where Lori Paige was caught watching "anime pornography".

When asked, Wiley was unable to remember the events of the week leading up to when he reported Lori Paige missing on 6/3/23. He seemed to not recall calling in sick to work and could not establish a reason for not being at work. When initially asked about his travel to Jacksonville, FL during the afternoon of 6/2/23, Wiley claimed to not remember this event. When pressed further, Wiley seemed to then remember a friend by the name of "Tim Brown" asking him for a ride to the Jacksonville airport. He stated Lori Paige refused to go with him as he traveled to Jacksonville. Records indicate Wiley did, in fact, travel to Jacksonville airport and then return home just before leaving for work on 6/2/23 at 11:00pm. Wiley claimed to not have contact information for "Tim Brown" readily available when asked but described him as a former college friend and provided a physical description. Wiley appeared confused when asked how and in what form he and "Tim Brown" arranged the travel to Jacksonville, FL airport (i.e., cell phone communication or otherwise).

Currently, the identity for "Tim Brown" is unconfirmed. Wiley has yet to provide any contact information for him.

Wiley was asked if there were any other devices which Lori Paige had access to in his home while she lived with him. Wiley stated that he had several old cell phones still in his possession as well as the computer Paige had accessed in the past. Wiley at one time stated he would provide these devices but has since changed his mind and has not provided them as of this writing, despite advice from counsel.

On 2/23/24 at approximately 2:30pm, Det. Megna contacted Antwan Wiley to provide 100 additional Missing Persons fliers of Lori Paige. During my contact with Antwan Wiley, we discussed several recent efforts made by detectives in this case and updated him with the current information about the case. Det. Megna also questioned Antwan Wiley about Lori Paige again and about any insight he has as to where she could have gone. During the discussion Antwan Wiley mentioned he had taught Lori Paige to swim during the summer of 2022, which contradicted Brooklyn Paige (grandmother) and Maranda White statements which suggested Lori Paige could not swim. Another inconsistency between Lori Paige's maternal family and Antwan Wiley is her maternal family's claim that Lori Paige was afraid of the dark. According to Antwan Wiley, Lori Paige was in no way afraid of the dark or scared to be outside in the dark.

Antwan Wiley could not remember any friends of Andrew that were named "Tim". Antwan went on to say that during Lori Paige's time at his home, he too had caught her viewing "anime pornography". It was only then that Antwan Wiley had learned from his brother that this was a reoccurring issue.

Consistent throughout interviews with Maranda White, Latonya White, Antwan Wiley, and Brooklyn Paige is that none feel Andrew Wiley would cause any harm to Lori Paige intentionally and all believe Lori Paige to have run away from Andrew Wiley's residence while he was working.

On 2/26/24, Det. Megna and Det. Childers contacted Symone Robinson via phone. Symone advised Lori and her sister (Amya) would use her (Symone's) laptop to play Roblox together. Symone advised the information had since been removed from laptop when she had to reset it. She noted that this was the only thing Lori used on her computer and that Lori did not use it unsupervised. Lori also spent the night at Symone's mother's house a few times and that her mother (Leshawnte Addison) would take Lori and Amya out sometimes. Lori was reportedly very well behaved and there were no issues. Symone advised that she was in military training during the time frame Lori disappeared. Symone remembered Andrew calling her after Maranda showed up announced to his residence (5/25/24). This led to her and Andrew arguing and eventually hanging up. They then spoke to each other the next morning. Sometime after that, the military took Symone's phone due to her being in a training environment. She did not get the phone back until sometime in mid-June

which is when she learned of Lori's disappearance. Symone noted that Andrew was feeling frustrated with the case because he felt as if he was being suspected of something. When asked, Symone did note that she knew Andrew knew someone named Tim but was not aware of him going to Jacksonville.

Upon a review of Andrew Wiley's phone records, it was learned that he had only been in contact with one person with the listed name of "Tim". This person was identified as Tim Costume with phone number 305-790-2373.

On 2/26/24, Det. Megna and Det. Childers contacted Tim Costume (305-790-2373) via phone. Costume stated that he had known Andrew since approx. 2009 when they attended school together. When asked the nature of their relationship he advised they were friends. Costume advised he had been to Tallahassee a few times in the last year but could not be sure of specific dates. He believed one of those times could have been in the summer, around June or May. Costume stated he always drives to Tallahassee. When asked, he advised he had never flown out of Jacksonville airport. He stated the last time he saw Andrew was in October but that he has never met Lori. He did not talk to Andrew about the subject of Lori's disappearance because it would upset Andrew. He stated that he and Andrew did not talk everyday but occasionally talked. This contradicts phone records for Wiley which indicate he and Costume speak by text or phone call daily and, during some conversations, for hours at a time.

On 2/27/24 at 3:00pm, a probable cause for the purpose of serving a search warrant to Wiley's residence at 2025 E Pinetree Blvd Apt 4A, Thomasville, GA was provided to Sgt Joshua Smith and Inv Jeremy Crosby of the Thomas County Sheriff's Office by Detective Jerry Megna of Tallahassee PD. The search warrant was drafted and signed by a Thomas County Georgia judge on 2/27/24.

On 2/28/24, Detectives with TPD and FDLE responded to 1051 Big Joe Road, Monticello FL, Jefferson Correctional Facility and seized Andrew's vehicle in conjunction with a search warrant. At the same time, Detectives with TPD and Thomasville Police Department served a search warrant on Andrew's residence. it should be noted the search warrant served to the residence was obtained by the Thomasville Police Department for jurisdiction arrangements.

While seizing the vehicle, Andrew laughed and stated, "do your thing" and "okie dokie" while Det. Megna explained to him the reasoning behind the search warrant

and the reasoning for wanting his old phones. Andrew asked to call his brother and was given his phone out of his car to do so. Andrew then left the scene in an unknown co-worker's car. Andrew's vehicle, white Dodge Charger FL Tag #CNXP53, was towed to Parkway Towing (252 Ross Road) for processing by TPD Forensics.

On 2/28/24 at 9:15am, members of the Tallahassee Police Dept with the assistance of Thomas County Sheriff's Office served the above search warrant on the residence of Andrew Wiley at 2025 E Pinetree Blvd Apt 4a in Thomasville, GA. The following items, along with photographs of the search warrant service, were collected:

It appeared based on dismantled, and factory reset devices that Andrew Wiley attempted to conceal data stored on these devices. It was also learned that the computer seized may have been one which Wiley recently purchased and was one that replaced a computer recently in his home to thwart detectives from examining the data of his previous computer. The previous computer was not located.

When Andrew arrived on scene to his residence, Detectives explained to him the search warrant and stood outside with him until the completion of the search warrant. Andrew stated, "They done took my baby", referring to his car that was seized. He also stated, "This is great, I love it". Andrew was again laughing. It was explained to Andrew that the search warrant was in reference to Lori's case.

Upon execution of the vehicle search warrant, the following items were seized:

- Firearm – Ruger SR 45 – Serial Number 380-76528
- Firearm Magazine – Ruger SR 45 – nine rounds in the magazine/ one round in chamber of firearm
- Ziploc bag containing fifteen .45 Winchester ammo rounds and one 9MM ammo round.
 - o It should be noted that Andrew Wiley's correction name tag was in the bag with the ammo. The name tag was removed and left with the vehicle.
- 3 paper maps of San Luis Park
- Car cleaning fluid
- Cleaning brush
- Blue journal
- Swabbing
- Passenger car seat upholstery
- Cut out from carpet.

A copy of the search warrant and return were left in the vehicle. I also noted in the vehicle was a receipt for a computer from Goodwill (2734 Capital Circle) on 2/27/24 and Andrew's US passport which was issued August 17, 2023. A check of Goodwill was later conducted, and they advised they do not keep track of who drops of

computers and that they wipe all hard drives when an item is received. Goodwill provided the video showing Andrew purchasing the new computer. When he is seen entering the store there is no computer with him.

The firearm and ammo were stored for safekeeping (per TPD policy). The maps were initially seized as evidence however it was learned the paper had a TPD's Sgt. Todd's phone number listed on the paper and these were given out during a canvass. However, Andrew was never a part of the canvass and given these later by someone. There was also approx. 20 of Lori's missing person flyers with the maps under the passenger car seat. The car cleaning fluid was an almost full bottle, but the cleaning description noted that it could clean up blood.

On 2/28/24, Andrew Wiley's vehicle was processed for evidence, to include a search for biological evidence related to the investigation into the probable death of Lori Paige by Wiley's hand. When the vehicle was processed, it was noted that floormats normally present and typically provided with a vehicle were absent. A bottle of cleaning spray was also discovered and had a label affixed which touted its ability to specifically clean or remove blood. When a bioluminescent spray which reacts to the presence of blood was applied to the interior of the vehicle, there was a visible reaction to places on the front passenger carpet and the front passenger door (to include the areas of the lower interior door and door jamb). The carpet was removed from the vehicle and sent to FDLE crime lab for processing. Along with the carpet sample, buccal standards from Maranda White and Andrew Wiley were sent to FDLE. Blood from Lori Paige was confirmed to be present in the carpet.

Det. Megna and I spoke with Captain Robison (Andrew's Supervisor) while at Jefferson Correctional Institute. Capt. Robison advised she had been Andrew's supervisor for approx. one year but was unaware until recently that Andrew had a daughter at all. He has never spoke about her, her disappearance, needing to change schedules or anything else for childcare arrangements. She stated Andrew rarely ever calls out sick and had no work-related injuries she was aware of. Captain Robison advised Andrew mostly keeps to himself and only knew that he used to date another previous employee (Symone Robinson). She had no other information to provide and did not note any changes in his behavior.

On 2/29/24, Brooklyn Paige was updated about the case status, steps being taken, exhaustion of leads and explained limited information about Andrew's behavior/cooperation. Brooklyn was surprised and did not understand why Andrew

would be acting this way. I advised Brooklyn to continue reporting any suspicious activity and continue contact with me.

On 3/4/24, it was discovered that Andrew Wiley had a previous [REDACTED] [REDACTED] Wiley had previously [REDACTED] (also listed names [REDACTED]). During the incident, [REDACTED] argued with Andrew about his faults as a parent. [REDACTED] stated she tossed a parenting book to Andrew. A fight ensued and Janie stated Andrew threw her down multiple times, punched her in the chest, and strangled her. She stated that while she was on her back, he held her arm down with one hand and strangled her with the other. She stated she could not breathe but did not lose consciousness. She stated Andrew continued to strangle her until her 10-year-old son came in with a frying pan and told Andrew to get off her, which she did. Andrew stated the book was thrown at him and that [REDACTED] attacked him. He stated he grabbed her by the shoulders and when she would not stop hitting him, he pulled [REDACTED] to the floor and got on top of her. He stated that he kept a hold on her shoulders, bit denied ever grabbing her throat. Andrew stated that she continued trying to hit and kick him until her son came in holding a frying pan. [REDACTED] told him to get off [REDACTED], which he did. Both of [REDACTED] children (10 and 12 years old at the time) witnessed the event and hit Andrew to get him off her. No arrest was made at the time due to the conflicting statements and injuries that could be consistent with both versions of events.

Detectives spoke with [REDACTED] at length via phone. In summary, [REDACTED] advised the following: She met Andrew when he was in the Army stationed in Colorado. They had a short relationship [REDACTED] [REDACTED] The relationship quickly went from sweet/charismatic to sour/violent. [REDACTED] stated Andrew had a drinking problem and was violent toward her. She briefly spoke about the above documented [REDACTED] and remembered her son hitting him with a pan. She stated she did not let her children around him without supervision because [REDACTED] She stated he was never violent with them but again pointed out her was not around them long/often. Within a few months they parted ways when she reported him to the ARMY [REDACTED] She had not spoken to him for many years after that. She noted that Andrew became very violent and hostile when drinking and that he had thrown rocks through her window.

In 2017, Andrew Wiley reached out to [REDACTED] through her social media and wanted to reconcile, [REDACTED] did not want this but did want to speak with him some. Over time things faded out until Andrew again reached out to her in 2021. He talked about living with his brother/his wife and becoming a correctional officer. In October 2021, they stopped speaking again due to other personal things in [REDACTED] life. In March of 2022, she remembered Andrew talking about his son staying with her and having reading problems. She did remember that he eventually told her that Lori was living with him because her mother left her in Tallahassee. She stated Andrew was upset by this and referred to Lori as "bad" and "fast". A few months after this, Andrew spoke about Lori being with him still and that he wanted to move to Atlanta. Approx. one month later, Janie had not heard from him (which was not uncommon as their communication was sporadic) and called him. Andrew stated Lori was missing and had been for a few weeks. [REDACTED] noted that Andrew was extremely non-chalant about the situation which confused her. She asked him if he was out handing out flyers or doing anything more to locate Lori. Andrew got upset and said, "I know where she at, she on the wrong side of town with her friends". Andrew spoke about wanting a new job and being upset that Maranda left him there. [REDACTED] pointed out that he was being insincere and should be taking it more seriously. An argument ensued and Andrew hung up on her. Janie stated she realized Andrew never truly changed and felt he was still the same person [REDACTED]. She then stopped talking to him. Approximately one month later, she received a message from Andrew stating his girlfriend found their messages and was upset. [REDACTED] had been unaware that he had a girlfriend and refused to continue to talk to Andrew. This was their last communication. [REDACTED] later left me a voicemail and stated she thought I should know that during her communications with Andrew, it seemed that when Lori was around it would remind Andrew of her mother (Maranda) and this may have made him angry. She stated she did not believe Andrew did anything to make her runaway but that she did not want to be with him.

On 3/5/24, a search warrant was sent to Google for geo-location information however they advised they no longer provide/have this information.

On 3/7/24, TPD received a copy of Andrew's [REDACTED] [REDACTED] It should be pointed out Annalise is Lori's middle name. It did not have dental or life insurance for her listed.

On 3/7/24, a subpoena was sent to Priceline regarding information for Andrew and Tim Costume. This was in relation to a phone call placed by Andrew Wiley to *Priceline* on 6/2/23 at approximately 2:56 PM for 55 seconds. On 3/14/24, results from the subpoena showed no activity for Tim Costume. However, it did show that Andrew Wiley purchased a one-way airline ticket for himself on 6/2/23 at 3:30 PM from Jacksonville, FL (JAX) to San Juan, Puerto Rico (SJU) via Delta Airlines. The flight time was for 6/3/23 1:21 PM with arrival in Puerto Rico at 10:32 PM (layover in Atlanta). The confirmation number for the airline was HNG7ML. The IP address associated to the transaction was 98.230.0.81 which returns to a Comcast customer in Tallahassee, FL. The subscriber information for the flight showed Andrew Wiley's known information including his address on Continental CT, his phone number at the time [REDACTED] and email awiley862@gmail.com. Records show he later requested a refund which was denied on 6/7/23. The credit card information only showed the last four numbers on the card as [REDACTED]. I spoke with the record provider of Priceline who could not confirm if the 6/7/23 was the same date the request for refund was submitted but did show that is when it was denied. Priceline sent two versions of the results to clarify this information. This is the only information Priceline had and they advised any other information would have to be sought through Delta Airlines.

A follow-up subpoena was conducted with Delta which did not yield any differing or new information with exception to the possible cost of the ticket as \$150.70. Delta also did not have any listed information for Tim Costume for the time frame requested.

A check of Andrew Wiley's known banking information/cards at the time (3/14/24) did not reveal any corresponding information about the credit card ending in the numbers [REDACTED] used to purchase the ticket. Due to Priceline not storing any other credit card information, no further follow-up can be conducted at this time. Phone records show that Andrew was in Tallahassee at the time of the call to Priceline and online booking confirmation, however approx. 30 mins after the flight was booked, he drove directly to Jacksonville Airport.

The FBI confirmed that Andrew only obtained a passport in August 2023 and not had one prior. He also had no history of international travel. It should also be noted that a passport is not required to enter Puerto Rico due to it being a US Territory.

Based on his behavior as it is unreasonable that a single parent who was scheduled to work on the night of 6/2/23 would drive to Jacksonville airport right after scheduling a one-way flight out of the country from said airport. Though the flight was scheduled for 6/3/23, his actions were out of character and suspicious considering he lied about the trip's intentions to police as well. Further, Andrew noted he and Lori had no trips planned around that time and no family members/friends said they were asked to watch Lori despite extensive interview with all. Coupled with the fact that Andrew attempted to destroy/wipe his cellular phones, it became readily apparent that he was lying to police surrounding the circumstances of Lori's disappearance.

On 3/13/24, Andrew contacted TPD for an update on his vehicle and the case. I advised that TPD would still be holding the vehicle at this time as evidence. I informed him that we were still working the tip information that came in from billboards.

On 3/18/24, Jacksonville Sheriffs' Office and Jacksonville Airport advised they had no viable leads concerning LPR (license plate reader systems), cameras or documented LEO interactions for Andrew Wiley on 6/2/23 or 6/3/23.

On 3/22/24, Antwan Wiley contacted the Tallahassee Police Dept about questions about Andrew Wiley having his vehicle returned. During that conversation, Antwan Wiley discussed Andrew's behavior regarding his reluctance to turn over any electronic devices to police in reference to locating Lori Paige. When in the past Antwan Wiley seemed uncertain as to why Andrew would not cooperate with this request, during the phone call with detectives on 3/22/24 he seemed more assured that the issue regarding the phones was more akin to Andrew Wiley being embarrassed by personal information on the devices rather than attempting to conceal criminal activity. When asked to elaborate how he knew this or elaborate on the nature of the information, Antwan Wiley would not provide an explanation.

On June 3rd 2023, Lori Paige was reported to have gone missing by her father, Andrew Wiley. The initial account of the report made by Wiley is that he left for work on or about 10:45pm on June 2nd, 2023 and arrived home to find Lori Paige missing at approximately 11:00am on June 3rd, 2023. He stated that it was routine for him to work overnight and leave Paige at home during that time. Initially, there

were no signs of foul play as the home did not appear to have signs of a struggle within. Wiley stated that Paige's backpack was also missing and told officers he believed she had run away as in the prior incident on May 8th, 2023. By November of 2023, Andrew Wiley had moved out of the home he shared with Lori Paige and moved to Thomasville, Ga. He also acquired a new phone number, despite knowing Paige was still missing.

In the previous case (TPD 23-81621) Paige had been missing for only 24hrs and when located later at school, informed detectives she had slept at a friend's residence nearby. Until June 3rd, 2024, this was the longest amount of time Lori Paige had gone missing. Ten months has elapsed since the time Lori Paige was reported missing on June 3rd, 2023.

As the investigation progressed through the exhaustion of all leads to the whereabouts of Lori Paige, it was learned that Paige was troubled with serious depression and displayed signs of resentment for her parents, Maranda White, and Andrew Wiley. In both households, it appeared she was left alone for hours at a time with no supervision and that this occurred from a very young age. There were also incidents in Paige's life of [REDACTED]

Paige's visitation with Andrew Wiley had been limited to times during her school breaks as Paige primarily lived in Nashville, TN with her mother, Maranda White. During the summer leading up to the 2022-2023 school year, Paige was with Wiley in Tallahassee, and it was anticipated she would return to Nashville with her mother prior to the start of the school year. White ultimately decided not to return to Tallahassee to retrieve Paige and Paige was unexpectedly left in the care of Wiley for the upcoming school year. According to Wiley, this led to Paige's behavior worsening as did her bouts of depression.

Despite issues of emotional neglect, Paige was able to befriend students at Griffin Middle School where she attended during the 2022-2023 school year. Students close to Paige stated that she rarely spoke about her parents and believed she was injured by her father after they observed injuries to Paige. Paige also spoke about her father having "beat" her for disciplinary reasons. Some students reported that they once observed Wiley striking Paige with a belt as she stood at the bus stop near her house for reasons that she did not immediately walk home after exiting the

school bus. When Wiley was asked about this, he admitted to “whooping” her with a belt but denied that this occurred in public. The date this occurred was not specific but believed to have occurred in the timeframe of April 2023 according to statements made by Wiley and the students who observed the incident. When Wiley was asked about injuries to Paige’s face which were observed by students, Wiley stated that this occurred sometime in March or April of 2023 and was the result of him having to restrain Paige during her attempt at running away. He said both he and Paige fell into a concrete culvert near their home, that he was injured during the incident as well, but no medical treatment was sought for either of them.

Due to the emotional instability that Lori Paige apparently underwent, canvasses were conducted in the areas near her home. Wooded areas, bodies of water and parks were searched to exhaustion. Canvasses including interviews with known sex offenders in the area and area neighbors were conducted without success. Video surveillance was sought with no leads developed.

Attempts to gather location data and phone record data for all subjects close to Lori Paige have been exhausted. Phone records and location analysis has been examined for any possibility of Paige being alive and hidden by her mother or father and any associates of theirs. At this time, Paige is believed to be deceased as there has been no sign of life from Lori Paige since May 25th, 2023, where Maranda White videoed a hostile interaction between her, Paige and Wiley in Tallahassee at Wiley’s home.

As the likelihood of Andrew Wiley’s involvement in Lori Paige’s death grew, the investigation turned to focus on Andrew Wiley. During questioning of those closest to him (brother and girlfriend) it was learned that his relationship was struggling with his girlfriend (Symone Robinson) and Andrew Wiley was having difficulty parenting Paige as she was becoming more rebellious (per brother, Antwan Wiley). Wiley’s brother discussed Wiley wishing to return Paige to her mother in mid-2023 but was convinced by his brother to keep her in Tallahassee and with him. It was also learned that Paige’s maternal grandmother (Brooklyn Paige) would assist Wiley with purchasing clothes and caring for Paige. However, Brooklyn Paige informed detectives that she felt Andrew Wiley lacked appropriate maturity to parent Lori Paige and appeared to struggle with caring for Paige.

Andrew Wiley had been cooperative with requests up until the point where he was asked to come to TPD for an interview. Wiley was told that the interview would

consist of discussing updates in the case and information learned from Maranda White in Nashville, TN. Wiley agreed to meet the next day at 9:00am (2/20) and appeared agreeable to the meeting.

Wiley had initially agreed to meet with detectives at 9:00am on 2/20/24 but did not arrive as scheduled. By 10:00am, Wiley had arrived in the Tallahassee area from Thomasville, GA and had not contacted detectives. He arrived at the home of Brooklyn Paige and then immediately drove to consult with legal counsel. Wiley's attorney then contacted detectives to arrange an interview for later in the day.

Wiley and his attorney arrived to TPD at approximately 2:30pm on 2/20/24. During the interview, Wiley was asked about travel to Jacksonville, FL on 6/2/23 in the hours prior to him having to be at work. Wiley at first denied remembering this incident, but then later stated that he drove a subject named "Tim Brown" the airport. He claimed this person to be a former college associate and gave a vague description of the subject. When asked how he arranged the drive, he claimed there was communication through cell phone, but no such activity existed in his phone records. Wiley's description of "Tim Brown" closely resembles a subject named Tim Costume, also a former college associate of Wiley. A later interview with Costume would reveal that Costume did not travel to Tallahassee to visit Wiley at that time and has never flown to or from Tallahassee or Jacksonville. Costume also alleged that he has never met Lori Paige and does not often speak with Wiley. Wiley would not provide a phone number for "Tim Brown" and claimed it was maintained on a different device than his current phone. It is believed that "Tim Brown" is a fictitious person meant to hide Wiley's true motive for travel to the Jacksonville airport on 6/2/23. Wiley could also not account for two days in which he called out of work and gave a reason as being sick for two days between 5/25/23 (last Paige known to be alive) and 6/3/23 when Wiley reported Paige missing.

During the interview, Wiley was asked to provide electronic devices (tablet computers, old but still working cell phones, computers) which Lori Paige could have accessed to utilize social media or the internet. Wiley was apprehensive about turning over these items and repeatedly asked why we would need them. After explaining that she could have used these devices to initiate contact with those seeking to do her harm and may have formed new accounts for social media, he and his attorney seemed agreeable to the reasonableness of the request. Wiley then

promised to provide the devices and attempt to provide passcodes for the devices. Wiley never provided the devices or a phone number for "Tim Brown" in the days after the request from detectives.

On 2/28/24 A search warrant was served on Wiley's home for the above sought devices. Wiley's vehicle was also seized due the suspicion that Wiley was attempting to hide his motives for travel to Jacksonville, FL and conceal devices in his vehicle being sought by law enforcement. It was learned that Wiley destroyed the devices in his home and rendered the data from them unattainable. He had also removed a computer from his home and replaced it with a newer computer between the time of his interview on 2/20/24 and the service of the search warrant to his home. Wiley refused to answer any questions regarding his efforts to destroy evidence which could potentially lead to finding his missing daughter. When Wiley's brother, Antwan, was informed about his behavior, he too seemed confused about Wiley's motive for keeping potentially helpful information from detectives.

Further review of Andrew Wiley's phone records revealed that Wiley contacted *Priceline.com*, a travel booking website for purchasing hotel stays, airline tickets and rental vehicles. The call was placed to Priceline.com on 6/2/23 while Wiley traveled to Jacksonville, FL airport. It was determined through subpoena that Wiley purchased a one-way ticket to Puerto Rico in his own name for departure on 6/3/23. Wiley never boarded the flight and appeared to request a refund for the purchase. He later went to work at 11:00pm and reported Paige missing the next day. He did not make an attempt to notify his place of employment prior to his travel to Jacksonville, FL seemingly making this endeavor a hasteful attempt to leave the continental United States. This is the same travel to Jacksonville, FL where Wiley claimed to have taken "Tim Brown" to the airport. Approximately 60 days later, Wiley received a passport from the US State Department and had never applied for a passport in the past. Wiley omitted and lied about his intentions for travel to Jacksonville, FL.

On 3/27/24, a search warrant for Tim Costume's historical phone records was submitted to confirm/disprove Andrews' alibi during the time he last saw Lori alive on 6/2/23. On 4/4/24, the records returned which showed Costume was not in Tallahassee during June 2023. Costume only traveled to Tallahassee on 10/26/23 through 10/29/23. Records did not show him travelling to Thomasville, GA or

Jacksonville, FL during that time. Costume and Andrew did communicate with each other on 5/28/23 for over 30 minutes and that Andrew called him on 5/29/23 (no answer). They did not speak again until 6/11/2023 when they spoke for 30 minutes.

On 4/8/24, Brooklyn Paige requested to come to TPD to contact Nancy Grace. Brooklyn explained she had just located a message from 2/7/24 from where the network tried to reach out to her. Brooklyn wished to request assistance in contacting them from a different number than her own because she did not want her information shared but did want to ask them to bring attention to Lori's case. Detectives assisted Brooklyn in this, and she contacted one of the employees, explaining that she did not wish to make a statement but did want them to spread Lori's case information to the public. She also provided them Andrew's number because she had recently talked to him, and he agreed to speak with the show as well.

Detectives then spoke with Brooklyn about her conversations with Andrew. Brooklyn expressed that Andrew did not seem concerned still and told her that he had been staying at his house in case police returned and that he was on administrative leave from his work. Brooklyn stated that on the date Detectives visited her and Andrew came to the police station for an interview (2/20/24), he first came to her house (already known). She stated he told her that he was coming to town for a meeting at 10:00 AM with a lawyer but came earlier to look for Lori but couldn't provide where he was looking. This was of note because Andrew had agreed to an interview with Det. Megna and I on 2/20/24 at 9:00 AM which he did not show and clearly had no intention of doing so at that time, therefore intentionally misleading police. He also would not respond to calls or texts from Det. Megna to see if he needed to reschedule.

Brooklyn agreed to a control call with Andrew. Andrew answered the phone and they spoke for a lengthy period. No new case information was learned however the following topics stood out as they spoke, which are as follows:

- Lori's birthday coming up: Brooklyn asked Andrew what he was planning to do for Lori's upcoming birthday which was only a few days away. Andrew would often redirect the question or seem as if he had not given it any thought. When she asked if they could do something at his apartment for her in her "new bedroom" such as lighting a candle, Andrew would change the subject. Brooklyn talked about getting something for Lori's birthday even though she was not home but what asked if he got her anything, Andrew said

he thought about it but could not actually name anything. He talked about a microphone at some point for videos that Lori could make but noted she never posted any. He did say Lori only used her school computer and was not allowed to use his.

- Photos of Lori: Prior to the phone call, Detectives showed Brooklyn the two photos shown to Andrew at the beginning of the investigation by Det. Drake. Both times Andrew identified the girls as Lori. The photos were shown to Brooklyn, but she stated they were clearly not Lori which Detectives had already determined. These photos were impounded as evidence. Brooklyn brought up the recently viral photo believed to be of Lori (girl wearing a pink shirt/Broward County) and noted that Andrew had stated he got a call about it from Virginia. Andrew did note the girl was not Lori upon seeing the photo.
- Looking for Lori: When Brooklyn would ask him what he was doing about looking for Lori, he stated he did not like social media and was only speaking to police and his family about it. This seemed odd as Andrew was not talking to police and rarely if at all reached out in the investigation. He would often reach out about his vehicle after it was seized but not much about looking for Lori or the steps taken in her search. His family members except for Antwan's also noted he did not speak about Lori's case much. He also said he was looking for her on the internet but could not advise how he was doing so. He did state that he was trying to see what people were saying about him on the internet.
- Phones/Why he was a suspect: When Brooklyn would ask him why police would think he was a suspect or lying to them, Andrew would state that it was only because he was the last person to see him. Brooklyn would bring up phones that the police wanted to look at, but Andrew changed the subject and did not provide a response to the specific question.
- If something happened to Lori: Brooklyn asked Andrew (not prompted) if something happened to Lori and that if someone was responsible for hurting her, what he thinks should happen to them. Andrew did not seem phased and danced around the answer like he couldn't provide one. Brooklyn became upset by this and even responded that she would hurt the person responsible for hurting Lori (which a normal response by parents who think someone hurt

their child). Andrew stated he wouldn't say any statements like that on the phone and indicated in case police were listening.

- Time frame: Andrew referred to Lori being missing during the call but kept changing how long she had been missing from 10 months to 11 months to 12 months.

The overtone of the call with Andrew and Brooklyn seemed to be that Andrew did not show much emotion or care about Lori being gone and almost seemed as if he was not planning on her being located. However, he did make statements about going to therapy and having mental health struggles in the case and not wanting to show them including references to suicide. He did not make any statements about being suicidal at the time. After the call concluded, Brooklyn was visibly upset and did not believe Andrews statements. Brooklyn advised she was having feelings of wanting to hurt the person responsible if Lori was hurt or murdered but this was a normal reaction when a grandparent believes their grandchild is hurt/murdered. Detectives spoke with her to calm her down and reassure her of the investigative steps taken and this was in the hands of LEO. Brooklyn stated she understood.

On 4/10/24, a search warrant was submitted to Verizon for text message content for Andrew Wiley. There was no indication of discussion about Lori Paige.

It was learned that the debit/credit card ending in [REDACTED] used to purchase Andrew's airline ticket on 6/2/23 was a Wells Fargo account in Andrew's name. A subpoena of the account was conducted and showed a \$30.00 purchase to Patient First was authored on 5/31/24. On 6/1/24 a purchase was also authorized to a Publix Pharmacy for \$42.95. Publix provided the receipt information for the purchase on 6/1/24 at 1415 (presumably 2:15 PM) was for "My Way 1.5 MG Tablet". A brief search showed My Way is a medicine to reduce chance of pregnancy after unprotected sex (common brand known for this is Plan B). The description of the medicine advised "take as soon as possible within 72 hours after unprotected sex. The sooner you take it the better it will work." And "if you vomit within 2 hours after taking the medication, call a healthcare professional to find out if you should repeat the dose.". Wiley's girlfriend (currently and reportedly during the time frame Lori went missing) is Symone Robinson. Robinson has been spoken to by Detectives

On 4/19/24, a search warrants were provided to Planned Parenthood for Lori's medical information. Due to Lori's age and the rights of protection Planned Parenthood provides, there is a reasonable belief she could have been seen/received treatment at Planned Parenthood. On 4/29/24, I received the results which showed there were no records, reports, notes, charts, or analysis reports for Lori.

On 4/19/24, a search warrant was obtained for Symone Robinson's phone records (229-224-2981) for phone location/call history from 5/20/23 to 6/17/2023 to confirm her location (at training) and to prove/disprove the anti-pregnancy medication could be for her. Phone records showed she was not in Tallahassee/Florida during this time.

On 4/19/24, a search warrant was obtained for [REDACTED] phone records (719-259-9611) for phone location/call history from 5/20/23 to 6/17/2023 to confirm her location (at training) and to prove/disprove the anti-pregnancy medication could be for her. Phone records showed she was not in Tallahassee/Florida during this time.

During a check of the purchases Andrew made during the time frame of Lori's disappearance, it was learned that he made a purchase at Family Dollar #2118 at 932 W Tharpe Street (Tallahassee) for \$31.18 on 5/30/23 at 12:48 PM. Det. Roth contacted Family Dollar and was able to obtain the receipt which showed a purchase for the following:

- Ombre Bath Rug 2PC (2 piece) set - \$12.00
- Memory Foam Rug Set 14 PC – \$15.00
- Oval Vanity Wastebasket 1.5 Gallon \$2.00
- Tax - \$2.18

This suggests a sudden immediacy to replaces items in a bathroom within the apartment where Lori Paige and Andrew Wiley lived at the time of her disappearance.

On 2/28/24, Andrew Wiley's vehicle was processed for evidence, to include a search for biological evidence related to the investigation into the probable death of Lori Paige by Wiley's hand. When the vehicle was processed, it was noted that floormats normally present and typically provided with a vehicle were absent. A bottle of cleaning spray was also discovered and had a label affixed which touted its ability to specifically clean or remove blood. When a bioluminescent spray which reacts to the

presence of blood was applied to the interior of the vehicle, there was a visible reaction to places on the front passenger carpet and the front passenger door (to include the areas of the lower interior door and door jamb). The carpet was removed from the vehicle and sent to FDLE crime lab for processing. Along with the carpet sample, buccal standards from Maranda White and Andrew Wiley were sent to FDLE. Blood from Lori Paige was confirmed to be present in the carpet.

On about 3/22/24, Antwan Wiley advocated for the release of Andrew Wiley's vehicle and in the conversation made excuses for Andrew's behavior for withholding electronic devices. When prompted to elaborate, Antwan Wiley would not provide the motive for Andrew to withhold these devices from police inspection. This would lead detectives to believe it possible that Antwan Wiley may have information about Andrew Wiley's involvement in Lori Paige's disappearance.

A device (older model iPhone) seized from Andrew Wiley's apartment on 2/28/24 was able to be accessed for data extraction. The results are as follows:

On June 1, 2023, at 12:01p.m., searches were conducted on Wiley's phone for different areas in Alabama and Georgia, and for driving directions from Tallahassee, Florida. The searched areas included bodies of water in the southeast region of Alabama and southwest region of Georgia, just past the Florida state line.

On June 1, 2023, at 12:17p.m., Wiley's device conducted searches for, "bad neighborhood tallahassee florida" and "Apalachicola National Forest dead body." At 12:23p.m., the device also searched, "where do police look to find missing kids." During the search, the device viewed a Quora page, on which a user asked the question, "Why would police stop looking for a missing child saying the delay of the search is based on where they are in the investigation, wouldn't they still need to find the child?"

On June 2, 2023, at 4:34a.m., Wiley's handset appeared to leave his residence via vehicle. The handset travelled through the Frenchtown areas, including Alabama Street, Brewer Street, Woodward Avenue, Delaware Street, Dewey Street, Dunn Street, and West 4th Avenue. It appears Wiley then travelled southbound via South Bronough Street to the West Orange Avenue and Lake Bradford areas, before traveling east to the Apalachee Parkway area, arriving

just east of Wal-Mart at approximately 5:29a.m. The device remained in that area until approximately 5:51a.m.

At approximately 5:52a.m., Wiley travelled eastbound on Apalachee Parkway, continuing into Jefferson County. Wiley proceeded north on Highway 19, into Monticello, Florida, then turned east onto Highway 90. Wiley remained in the downtown Monticello area until approximately 6:30a.m., before proceeding north into Georgia via Boston Highway. At approximately 6:28a.m., and approximately 1.5-miles north of the Florida-Georgia line, Wiley then turned onto Mitchell Road, which travels northwest from Boston Highway.

Both sides of Mitchell Road appear rural and wooded from the roadway. On the right (southeast) side of the road, is a large plantation which is currently being used for recreational quail hunting. Wiley's handset travelled for approximately 1.85-miles on Mitchell Road, then turned around and proceeded back toward Boston Highway. At approximately However, Wiley's handset did not continue to the Highway. At approximately 6:53a.m., Wiley's handset stopped providing location data, but logged a location at 7:01a.m., which showed the device was in a field on the southeast side of the road, approximately 800-feet from the roadway. At 7:17a.m., Wiley's handset proceeded south on Boston Highway, back into Florida.

Thereafter, Wiley's handset travelled to the Thomasville, Georgia area. Wiley's handset remained in the area of E Pinetree Boulevard and Ben Grace Drive from approximately 7:52a.m. to 7:59a.m., before becoming mobile, again. Wiley's handset subsequently returned to the Tallahassee area, arriving in the area of his residence around 8:44a.m.

The areas of Mitchell Pond Rd and Boston Hwy were extensively searched with the use of cadaver dogs in multiple teams, members of the Thomas County Sheriff's Office and TPD detectives. Private properties were searched with property owner consent. On 4/5/2025, the remains of a human, teenage female were discovered in the very area of thick brush near (within 30 meters) where Wiley's cell phone had shown his location on 6/1/2023. Several bones of the same skeleton were located and submitted to FDLE for DNA comparison. **On 4/11/2025, FDLE was able to confirm that the skeletal remains are that of Lori Paige.**

Evidence discovered during this investigation would lead a reasonable person to believe that sometime on 6/1/2023, Andrew Wiley did kill his only daughter, Lori Paige and dump her body in the wooded areas of Thomas County, GA. DNA evidence suggests Paige was bleeding within Wiley's vehicle and that Wiley used his vehicle to travel to Thomas County to dispose of her remains. Evidence of Wiley's purchases leading up to the murder of Paige suggests there was likely abuse of Paige occurring, [REDACTED] It appears that Wiley took preparations to flee the continental United States and attempted to cover up this by lying about the reasons for his travel to the Jacksonville airport on 6/2/23. Wiley took extensive measures to conceal his actions to include destroying his electronic devices.
